

## Hitachi Announces Plan on Year-end Dividend

**Tokyo, April 26, 2019** — Hitachi, Ltd. (TSE:6501) today announced that the Board of Directors decided on a plan for the year-end dividend for the fiscal year ended March 31, 2019, which had not been decided, as shown below in view of earnings performance and other factors. The year-end dividend is scheduled to be finally authorized by the Board of Directors in May 2019.

\*1 The year-end dividend consists of an ordinary dividend of 45 yen and a special dividend of 5 yen in consideration of the level of achievement of targets set out in the 2018 Mid-Term Management Plan.

\*2 The calculation of the total amount of the year-end dividend is based on 965,606,010 shares, which deducted 1,086,667 shares of treasury stock from total issued shares of 966,692,677 shares as of March 31, 2019.

\*3 Hitachi conducted a share consolidation of every five shares of common stock into one share on October 1, 2018. The dividends per share for the fiscal year ended March 31, 2018 and interim dividend per share for the fiscal year ended March 31, 2019 are indicated in amounts factoring in the impact of the share consolidation. Without reflecting the reverse stock split, the interim and year-end dividends per share for the fiscal year ended March 31, 2018 are 7 yen and 8 yen, respectively, totaling 15 yen for the said fiscal year, and the interim dividend per share for the fiscal year ended March 31, 2019 is 8 yen.
