# Hitachi Announces Selection of Director Candidates Aimed at Strengthening Global Expansion of Digital Business

To become a global leader in the Social Innovation Business, three new director candidates have been selected.

**Tokyo, March 30, 2020** – Hitachi, Ltd. (TSE: 6501) today announced that director candidates to be proposed at its annual general meeting of shareholders in 2020, in accordance with a resolution at a meeting of Nominating Committee that convened today.
